NOTICE TO PORT OF PORTLAND TARIFF USERS

**RE: PORT TARIFF NO. 8 – EFFECTIVE JULY 1, 2008
(Tariff No. 8 cancels and replaces Port Tariff No. 7)**

The electronic form of the Marine Tariff will govern in the event of any conflict with any paper form of the Marine Tariff or this notice.

Section I – Miscellaneous Rate Tables

The following item has increased:

1000.000 – Fresh Water Service

1000.002 – Water Consumption

From \$1.77 to \$2.07 per hundred cubic feet or fraction thereof

Section 4 – Container Cargo Rules and Rate Tables

The following has been eliminated:

4820.801 – Placarding – Removal - \$86.00

The following has been amended; see Section IV – Container Cargo Rules – item 4. Special Hazardous Cargo Handling Services, sections A, B, and C for applicable hazardous cargo classes. Effective date is December 1, 2008:

4800.000 - Hazardous Cargo

4850.010 – Container handled - \$109.00

4850.020 – Container storage after the first business day - \$100.00

Language has changed from “Container storage after the first business day” to “Container storage fee / day after the first business day.”

Section 6 – Longshore Labor Services

The Longshore Labor Services rate table items 6305.000 through 6345.000 have been amended.

6371.000 - Gang Rates – Container-Multiple Gang, following shifts have been changed:

6371.600 – 1st Shift

Increased from \$1,939.00 to \$2,210.00

6371.605 – 2nd Shift

Increased from \$2,322.00 to \$2,430.00

6371.630 – 3rd Shift

Increased from \$2,827.00 to \$3,050.00

6371.635 – 3rd Shift Overtime

Increased from \$3,066.00 to \$3,296.00

6374.000 Gang Rates – Break Bulk Gang, the first shift has changed:

6374.600 – 1st Shift

Increased from \$3,547.00 to \$3,880.00
